## Access Passport – FREE for qualifying families

To qualify, you must provide a copy of your most recent tax return or assistance grants for the last three months as proof of income. Please see chart below for income guidelines.

### Benefits:

- Discounts on programs, seasonal events and Museum birthday parties.

2 people	\$19,123 per year \$1,594 per month
3 people	\$24,089 per year \$2,007 per month
4 people	\$29,055 per year \$2,421 per month
5 people	\$34,021 per year \$2,835 per month
6 people	\$38,989 per year \$3,249 per month
7 people	\$45,953 per year \$3,663 per month
8 people	\$48,919 per year \$4,077 per month
